Criminalizing Repeat Drunken Driving, Providing Access to a Deceased Persons Social Media, Tougher Penalties for Violating Cell Phone-While-Driving Ban & Stopping Christie Housing Fund Raid Top Thursday Assembly Agendas

Forgiving College Loans When a Student Dies, Tougher Penalties for Gun Possession on School Campus, Boosting Solar Market, Addressing College Tuition Concerns & Suspending Medical License for Illegal Waste Disposal Also on Tap

(TRENTON) - Criminalizing repeat drunk driving after a Vineland man racked up five offenses in just over a month, giving an executor access to a executors access to a deceased person's social media web sites amid reports of parents who fought to access a deceased child's Facebook page, tougher penalties for violating the state's ban on hand-held cell phone use while driving and stopping the governor's proposed affordable housing fun raid top Thursday's Assembly agendas.

Forgiving college loans when a student dies, tougher penalties for gun possession on a school campus, boosting the solar energy market, addressing college tuition concerns and suspending medical licenses for illegal waste disposal are also on tap.

Highlights include:

· A bill (A-3057) to criminalize repeat drunk driving offenses. It's sponsored by Nelson Albano and Matthew Milam (both D-Atlantic/Cape May/Cumberland), Charles Mainor (D-Hudson) and John Burzichelli (D-

Gloucester/Salem/Cumberland). The bill comes after a Vineland man has racked up five drunken driving offenses in just over a month. The bill will be heard at 2 p.m. by the Assembly Law and Public Safety Committee.

- · Legislation (A-2943) sponsored by Assembly Majority Leader Lou Greenwald (D-Camden/Burlington) to allow executors access to a deceased person's social media web sites. It's to be heard at 11 a.m. by the Assembly Consumer Affairs Committee and comes amid reports of parents who fought to access a deceased child's Facebook page.
- · Legislation (A-2199 and A-1074) to make violating the state's hands-free cell

- phone law as reckless under vehicular homicide and assault by auto statutes. The bills are sponsored by Paul Moriarty (D-Gloucester/Camden), Charles Mainor (D-Hudson), Gabriela Mosquera (D-Gloucester/Camden), Annette Quijano (D-Union) and Albert Coutinho (D-Essex). They'll be heard at 2 p.m. by the Assembly Law and Public Safety Committee.
- · A bill to prevent Gov. Chris Christie from raiding affordable housing trust funds. The bill (A-2950) is sponsored by Assembly Speaker Pro Tem Jerry Green (D-Union/Middlesex/Somerset). It will be heard at 2 p.m. by the Assembly Housing and Local Government Committee.
- · A measure (A-748) sponsored by Peter Barnes (D-Middlesex), Linda Stender (D-Union/Middlesex/Somerset), Upendra Chivukula (D-Somerset/Middlesex) and Celeste Riley (D-Gloucester/Salem/Cumberland) to direct the state to forgive student loans in the event of a borrower's death. It's to be heard at 10 a.m. by the Assembly Higher Education Committee.
- · A bill (A-1888) to suspend the license of any medical professional who illegally disposes medical waste. It's sponsored by Nelson Albano and Matthew Milam (both D-Atlantic/Cape May/Cumberland) and Majority Leader Lou Greenwald (D-Camden/Burlington). It stems from the 2008 incident in which several beaches were closed after a dentist dumped needles in the ocean. It will be heard at 1 p.m. by the Assembly Regulated Professions Committee.
- · A bill (A-1216) sponsored by Linda Stender (D-Union/Middlesex/Somerset) to upgrade the penalty for unlawful possession of a firearm on the grounds of an educational institution. It's to be heard at 2 p.m. by the Assembly Housing and Local Government Committee.
- · Legislation (A-1083) sponsored by Annette Quijano (D-Union), Pamela Lampitt (D-Camden/Burlington), Celeste Riley (D-Gloucester/Salem/Cumberland) and Valerie Vainieri Huttle (D-Bergen) to require the state to develop and distribute student loan repayment information for high school students. It's to be heard at 10 a.m. by the Assembly Higher Education Committee.
- · A bill (A-2966) sponsored by Upendra Chivukula (D-Somerset/Middlesex) to reinvigorate New Jersey's solar energy market. It's to be heard at 10 a.m. by the Assembly Telecommunications and Utilities Committee.
- · Legislation (A-1521-1524) to slash red tape to help boost job creation sponsored by John Burzichelli (D-Gloucester/Salem/Cumberland), Annette Quijano (D-Union), Ralph Caputo (D-Essex), Ruben J. Ramos Jr. (D-Hudson), Craig J. Coughlin (D-Middlesex) and Peter J. Barnes III (D-Middlesex). They'll be heard at 10 a.m. by the Assembly Regulatory Oversight and Gaming Committee.
- · A bill (A-2144) to limit fees charged in connection with prepaid debit accounts. It's sponsored by Linda Stender (D-Union/Middlesex/Somerset), Troy Singleton (D-Burlington), Benjie Wimberly (D-Passaic/Bergen), Marlene Caride (D-Bergen/Passaic) and Daniel R. Benson (D-Mercer/Middlesex). It's to be heard at 10 a.m. by the Assembly Financial Institutions and Insurance Committee.
- · A bill (A-1277) sponsored by Craig J. Coughlin (D-Middlesex) and Patrick J. Diegnan Jr. (D-Middlesex) to increase production limitations for brewpubs. It's to be heard at 2 p.m. by the Assembly Law and Public Safety Committee.
