Complainant Mo Hill for Mayor, by and through his counsel, Cutolo Barros LLC,  
complains of the Respondents as follows:

**THE PARTIES**

1. Complainant “Mo Hill for Mayor” is a Single Candidate Committee formed for the purpose of supporting the election of candidate Maurice “Mo” Hill for the Office of Mayor of Toms River in the November 2019 General Election (the “Hill Campaign”).

2. Respondent “Petro for Toms River” is a Single Candidate Committee formed on June 24, 2019 for the purpose of supporting the election of candidate Johnathan Z. Petro for the Office of Mayor of Toms River in the November 2019 General Election.

3. Respondent “Petro Team for Toms River 2019” is a Joint Candidates Committee formed on September 9, 2019 for the purpose of supporting the election of candidates Jonathan Z. Petro for the Office of Mayor of Toms River and Michelle Williams, Andrew Boyle and Karin Sage for Council (referred to collectively with “Petro for Toms River” as the “Petro Campaign”).

4. Respondent Jonathan Petro is a candidate Johnathan Z. Petro for the Office of Mayor of Toms River in the November 2019 General Election.

5. Respondent Toms River Democratic Organization is a political entity located in Toms River, New Jersey.

6. Respondent Ocean County Young Democrats is a political entity located in Ocean County, New Jersey.

7. Respondent Ocean County Democratic Party is a political entity located in Ocean County, New Jersey.

#### **FACTUAL BACKGROUND**

8. Ryan Protter is the president of an entity entitled “Riverside Strategies,” which is claimed to have created and managed the field program for the Petro Campaign in the November 2019 General Election and is actively involved in the Petro Campaign (“Protter”). A true and accurate copy of the LinkedIn profile for Ryan Protter is attached hereto as **Exhibit A**.

9. Protter is the President of the Toms River Democratic Organization (the “TRDO”).

10. Protter is the President of the Ocean County Young Democrats (the “OCYD”).

11. Protter is the Chairmen of the Balloting Committee of the Ocean County Democratic Party (the “OCDP”).

12. Protter is also an employee of the Ocean County Board of Elections.

13. On June 24, 2019, the Petro Campaign filed a Form D-1 with the Election Law Enforcement Commission (“ELEC”). The Form D-1 lists “9 Robbins Street, Toms River, New

Jersey” as the mailing address for the Treasurer of the Petro Campaign. A true and accurate copy of the Form D-1 filed by the Petro Campaign is attached hereto as **Exhibit B**.

14. The offices of the law firm of Carluccio, Leone, Diamond, Doyle and Sacks, LLC, are located at 9 Robbins Street, Toms River, New Jersey (the “Firm”).

15. The TRDO holds its meetings at the Firm’s offices. A true and accurate copy of a social media advertisement for a TRDO meeting at the Firm’s office is attached hereto as **Exhibit C**.

16. On or about September 21, 2019, large numbers of residents of Toms River received an undated letter which purports to be from an entity entitled “TR Residents Against Overdevelopment” which lists an address of 1358 Hooper Ave. #206, Toms River, New Jersey 08753 (the “Letter”). A true and accurate copy of the Letter is attached hereto as **Exhibit D**.

17. The address of 1358 Hooper Ave. #206, Toms River, New Jersey 08753 is the address for a UPS Store location in Toms River which provides mailboxes for rent to the public (the “UPS Store”).

18. No business entity bearing the name “TR Residents Against Overdevelopment” is registered to with the State of New Jersey.

19. Despite the fact that no political entity bearing the name “TR Residents Against Overdevelopment” is registered with the New Jersey ELEC, the Letter includes language in the footer which reads “Paid for By Toms River Residents Against Overdevelopment, 1358 Hooper Ave. #206, Toms River, NJ 08753.” See Exhibit C.

20. The Letter attempts to impugn the Hill Campaign by, among other things, hurling unfounded allegations of “deal-making” between Mo Hill and “the Toms River Jewish Community Council and North Dover religious leaders” concerning various zoning and land use issues. See Exhibit C.

21. The Letter even presupposes that “some people will say this letter is anti-Semitic.”  
See Exhibit C.

22. In the closing paragraph, the Letter attempts to solicit votes for the Petro Campaign by stating that “Jonathan Petro will have my vote for Mayor on November 5<sup>th</sup>, and we hope he will have your vote as well.” See Exhibit C.

23. The Letter does not identify the treasurer of the “TR Residents Against Overdevelopment.”

24. Box number 206 at the UPS Store is rented under a fictitious name of “TR Residence [*sic*] Against Overdevelopment.” The phone number for the entity is listed as “(609) 240-5850.” A true and accurate copy of a screenshot of the computer at the UPS Store displaying the rental information for Box 206 is attached hereto as **Exhibit E**.

25. The phone number of (609) 240-5850 belongs to Ryan Protter. A true and accurate copy of a background report listing said telephone number as belonging to Ryan Protter is attached hereto as **Exhibit F**.

26. Further information provided by the UPS Store confirms that Box 206 is rented by Ryan Protter. A true and accurate copy of a printout of the renter information for Box 206 at the UPS Store is attached hereto as **Exhibit G**.

27. On October 4, 2019, the “Petro Team for Toms River 2019” filed a Form A-2 with ELEC, which contains a sworn statement that less than \$14,000 was spent by the “Petro Team for Toms River 2019” in the 2019 General Election. A true and accurate copy of the Form A-2 filed by the “Petro Team for Toms River 2019” is attached hereto as **Exhibit H**.

28. Ryan Protter, together with the Petro Campaign, the OCDO, the OCYD’s, the OCDP and/or the TRDO rented a mailbox at the UPS Store under the name of a fictitious entity to attempt to unlawfully circumvent the reporting requirements of the Campaign Contributions and



Expenditures Reporting Act and/or ELEC Regulations and to hide from public view the true activities of the Respondents.

29. Ryan Protter, together with the Petro Campaign, the OCDO, the OCYD's, the OCDP and/or the TRDO unlawfully authored and/or coordinated the distribution of the Letter to Toms River residents in an attempt to solicit votes for the Petro Campaign in the 2019 General Election.

#### COUNT ONE – FAILURE TO DISPLAY POLITICAL IDENTIFICATION INFORMATION

30. The Complainant repeats and realleges the allegations set forth in the preceding counts of this Complaint as if set forth herein at length.

31. The Letter is labeled as being from a fictitious entity.

32. The Letter was, in fact, authored and distributed by Ryan Protter in his capacity as a campaign consultant and/or employee of and in coordination with the Petro Campaign and/or through his positions with the OCDO, OCYD's and/or TRDO in an attempt to solicit votes for the Petro Campaign.

33. The Letter does not meet the political identification requirements of N.J.A.C. 19:25-13.2 and/or N.J.A.C. 19:25-13.3 or other applicable law as it does not identify the entity that is truly responsible for the Letter and expenditures associated therewith on the Letter itself.

34. The Letter does not identify the Treasurer of the campaign or other political committee responsible for the communications.

35. Therefore, one or more of the Respondents have committed a *per se* violation of the cited regulations.

#### COUNT TWO – FAILURE TO REPORT COST OF POLITICAL COMMUNICATION

36. The Complainant repeats and realleges the allegations set forth in the preceding counts of this Complaint as if set forth herein at length.

37. Neither the Petro Campaign, the OCDO, OCYD's and/or TRDO have reported the expenses associated with the letter to ELEC as required by N.J.A.C. 19:25-10.11 and other applicable law.

38. Therefore, one or more of the Respondents have committed a *per se* violation of the cited regulations.

**WHEREFORE**, the Complainant demands that ELEC initiate an investigation of the Respondents and take the appropriate enforcement actions against one or more of the Respondents for the violations of law cited herein or which may be discovered hereafter.

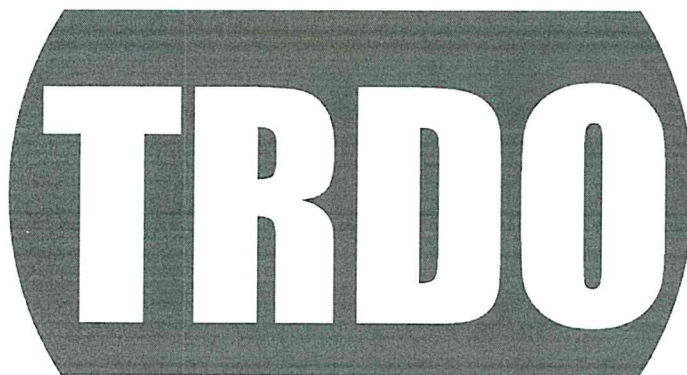

## TR Residents Against Overdevelopment

Dear Neighbor,

In June of 2019, Mo Hill won the hotly contested Republican primary election for Mayor of Toms River. Just one month earlier, he met with the Toms River Jewish Community Council and North Dover religious leaders. They struck a deal behind closed doors, and Councilman Hill secured the Orthodox Jewish "block vote," which delivered him approximately 700 votes. He went on to win the Primary Election by just 500 votes.

The deal-making that secured the election for Hill was not known at the time. Here's what we now know:

- **May 2019:** Mo Hill's campaign received a \$2600 donation from Scott Gartner, who threatened to sue Toms River with a "\$500,000 war chest," unless the zoning laws were changed to allow more religious buildings. Hill received another \$2600 donation from Efraim Ziegfried of the Toms River Jewish Community Council. Source: Asbury Park Press, June 21, 2018; NJ Election Law Enforcement Commission
- **June 2019:** Mo Hill received over 70% of the vote in the five North Dover voting precincts with the highest population of the Orthodox Jewish block vote. Hill received just 38% of the vote in the rest of Toms River. Source: June 2019 Election Results (Ocean County Clerk)
- **July 2019:** Mo Hill met with Scott Gartner in his home for several hours for a private discussion, after Gartner demanded zoning changes and specific public amenities for North Dover, like more street lights. Source: Shore News Network, July 31, 2019
- **August 2019:** Mo Hill announced a plan to "conduct an inventory of street lights that will reveal areas that need additional lighting." Hill stated, "Because we have more people walking in the northern sections, we need to increase the lighting out there." Source: Asbury Park Press, August 14, 2019
- **September 2019:** The Land Use Committee (which includes Mo Hill) authorized a plan to reduce the minimum requirements for religious buildings in North Dover from 10 acres down to 2 acres. Source: Toms River Land Use Committee Agenda, 9/13/19

I know some people will say this letter is anti-Semitic. It is not. People have a right to live where they want to live and worship how they want to worship. We are calling out the political leaders and political organizations that are backing Mo Hill, who make political donations and endorse political candidates. The issues involve planning and zoning for our township, including concerns like traffic, infrastructure and density of development. We believe that the agenda of Mo Hill and his political supporters is contrary to what most Toms River residents want.

This November, Mo Hill will be running against Jonathan Petro in the General Election to determine who will be Toms River's next Mayor. In a recent letter to the Asbury Park Press, Mr. Petro wrote, "I will uphold Toms River's 10-acre zoning rules for religious buildings, which have been in place since 2009. I will not cave to special interest groups." Jonathan Petro will have my vote for Mayor on November 5th, and we hope he will have your vote as well.

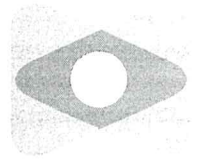
