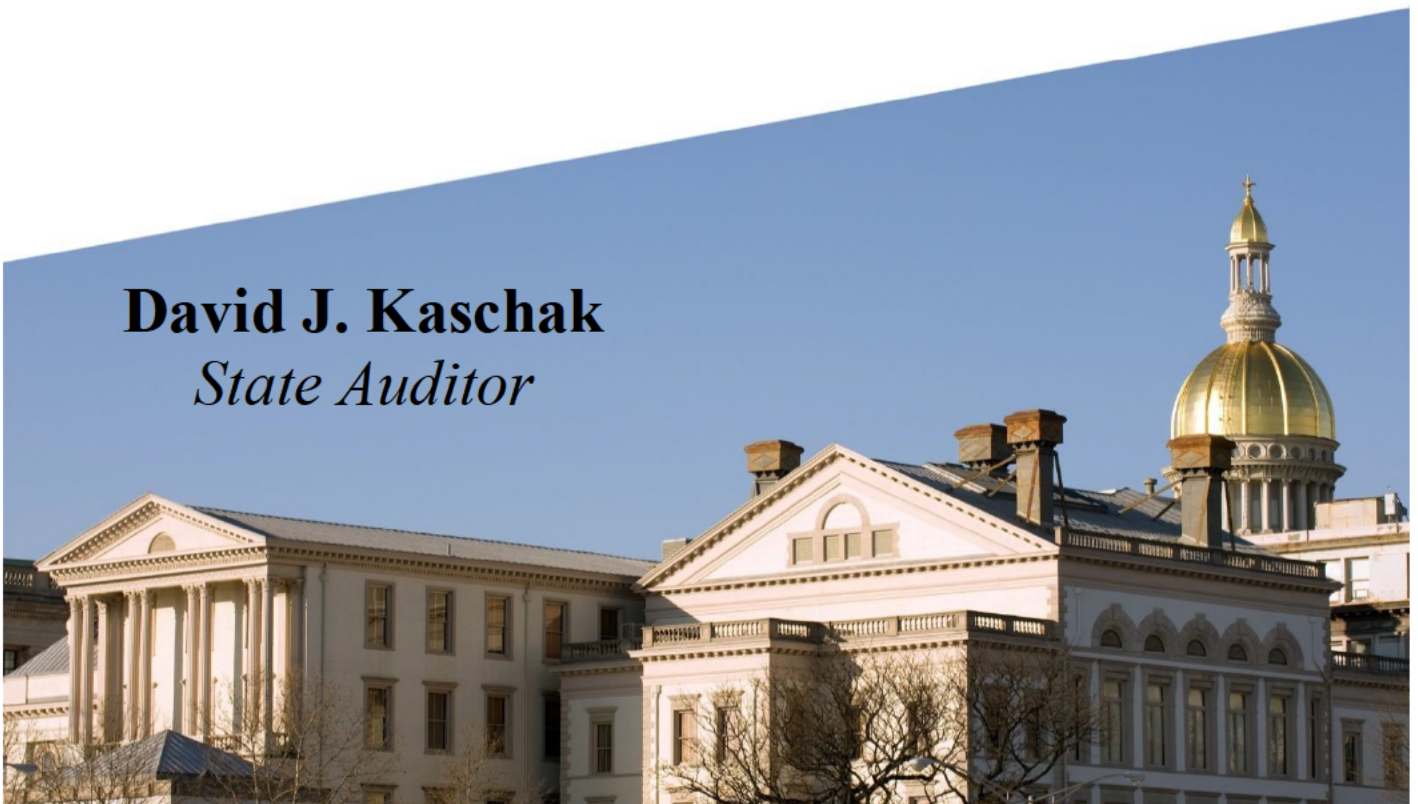

Enclosed is an updated informational report which provides an overview of the \$6.2 billion allocation the state received on May 19, 2022 from the United States Department of the Treasury under the American Rescue Plan, State Fiscal Recovery Fund (SFRF).

A summary of appropriations of the SFRF is provided on pages 1 through 7. As of March 31, 2023, the state had allocated \$5.2 billion and spent \$1.1 billion of its SFRF funds.

### State Fiscal Recovery Funds (SFRF)

On May 19, 2021, the state received \$6.24 billion in SFRF monies. The determination of eligibility of the specific programs, projects, and uses recommended to be funded with SFRF funds is made by the Executive Director of the Governor’s Disaster Recovery Office subject to the approval of the Director of the Division of Budget and Accounting. Funding recommendations are subject to the approval of the Joint Budget Oversight Committee (JBOC). The Department of Community Affairs, Division of Disaster Recovery and Mitigation is the state’s designated SFRF grants manager.

As of March 31, 2023, the following amounts of the SFRF funds have been allocated for the following purposes (additional funds received by the state and distributed to non-entitlement units of local government (NEUs) are not included).
