**CERTIFICATION OF
SENATOR MICHAEL L. TESTA**

I, Senator Michael L. Testa, of full age, hereby certifies as follows:

1. I presently serve as State Senator to New Jersey's 1st Legislative District, and as such, I am fully familiar with the facts set forth herein. This Certification is submitted in furtherance of an application to intervene as *amicus curiae*.
