

A1743 Reynolds-Jackson/ Quijano/ Collazos-Gill/Rodriguez	Requires law enforcement officer to reveal facial identity during certain public interactions and to present sufficient identification prior to arresting or detaining person.
A4070 Quijano/Park/Greenwald (pending intro and referral)	Establishes "Privacy Protection Act"; concerns collection and sharing of certain personal information.
